The airline will be operating direct, 4x weekly flights between Mumbai and Doha, starting from 15 December 2023 using its A 321neo aircraft. Bookings for the flights are being progressively opened on all channels, including <u>Vistara's website</u>, mobile app, and through travel agents.
